### **COOKIE POLICY**

The website fence.finance (the "**Platform**"), for which Fence Technology Spain, S.L. is responsible, uses its own (technical and preference) cookies and third-party analytical cookies for the purposes established in this policy.

# 1. DATA CONTROLLER

Fence Technology Spain, S.L. ("Fence") is a legitimate operator of the Platform and is the data controller of the personal data collected through its operation of the Platform or generated by its cookies' use. Fence's contact email for these purposes is the following: legal@fence.finance

#### 2. WHAT IS A COOKIE? WHAT OTHER TRACKING TECHNOLOGIES EXIST?

Cookies are files that are downloaded and stored on the user's computer or device (e.g. tablet or mobile phone) for the purpose of storing and obtaining information (including, personal data such as IP address) about the browsing habits of the user when the user visits the Platform. The cookies have diverse purposes, such as recognizing the user each time he or she accesses the Platform, obtaining information on the user's browsing habits on the Platform, customizing the way the content is shown or creating profiles based on the user's browsing preferences on the Platform and on the Internet.

However, there are other technologies similar to the cookies for the collection of information through the use of the Platform such as tracking pixels or beacons. These technologies allow us to know if a certain email has been opened or if there has been an interaction with a Platform's content, for example.

# 3. Types of cookies used in the platform, purposes and duration

The Platform only allows the use of cookies indicated in the following sections.

### 3.1 TECHNICAL AND FUNCTIONAL COOKIES

**Technical cookies** are those necessary for the browsing and use of the Platform. This kind of cookies allows the access to the different options or services included in the Platform (e.g. data traffic and data communication control, session's identification, access to restricted areas, remembering the elements that make up an order or an operation, perform the purchase process of an order, manage payment or use security elements during navigation). **Functional cookies** or preference cookies are those that allow to recall information for the user to access the Platform with certain characteristics that may differentiate their experience from that of other users (such as, for example, the language, the number of results to be displayed when the user performs a search, the appearance or content of the service displayed on the Platform).

The use of these cookies is necessary for the use and operation of the Platform (technical cookies) or derives from the characteristics of the Platform expressly selected by the user (functional cookies) so it does not require the consent of users and are automatically implemented on devices.

These cookies are stored as long as it is necessary for the purpose for which they were collected.

# 4. LEGAL BASIS

The processing of your personal data is necessary for the purposes indicated above and the legal basis are: (i) the execution of the relationship of the Platform with the user for technical or functional cookies; or (ii) the user's consent, which is granted when the user clicks the "Accept" button included in the cookie notice or when the user clicks the button included next to each type of cookie in the Section 3 "TYPES OF COOKIES USED IN THE

PLATFORM, PURPOSES AND DURATION". The user can withdraw the consent at any time through the buttons included in the previous section.

# 5. RETENTION PERIOD

The retention period of cookies will depend on the type of cookie and its owner as indicated in the information and links included in the section 3 above.

# 6. DISCLOSURE OF DATA AND INTERNATIONAL DATA TRANSFERS

Some of the controllers of third-party cookies listed above are located outside the European Economic Area ("EEA"). You can find out about the international transfers that, as the case may be, are made by the third parties identified in this policy in their corresponding policies (see the links provided in <u>Section 3 above</u>).

Additionally, your personal data may be communicated to competent authorities in the exercise of their functions in compliance with legal obligations or authorities' requests.

# 7. USER'S RIGHTS

The user can exercise the rights of access, rectification, erasure, objection, restriction of processing, to withdraw the consent previously expressed and to data portability, where applicable, with respect to the processing for which Fence is the data controller, by writing an email (and providing evidence of the user's identity) addressed to legal@fence.finance or by letter addressed to the registered office of Fence. In addition, the user has the right to file complaints with the competent data protection authority, in the case of Spain, the Spanish Data Protection Agency (Agencia Española de Protección de Datos) (www.aepd.es).
